305' Total Depth. Red Bed. Finished drilling 17-1/2" hole @ 9:30PM, 6-11-53. Ran a total of 7 jts. 13-3/8" CD 36# Armo SW SJ Casing set @ 296' and cemented w/ 250 sz. cement. Pumped plug to 281' @ 12:20AM, 6-12-53, w/ max. pump pressure of 250#. Cement circulated. After WOC for 12 hours, tested casing for 1/2 hour w/ 800# - no pressure drop. Drilled cement from 281' to 305' and tested casing for 1/2 hour w/ 800# - no pressure drop. Started drilling formation and 12 1/4" hole @ 12:15AM, 6-13-53.
