10090' - Total Depth - Lime. Finished drilling 7-7/8" hole @ 8:00AM, 5-27-53. Ran a total of 298 jts. 5-1/2" OD Casing set @ 10067' w/ 500 sz. cement. Plug pumped to 9995' @ 10:15AM w/ max. pump pressure 2350#. Ran Temperature survey - found top of cement outside 5-1/2" Casing @ 8123', or 63.6% fill. After WOC for 2 1/2 hours, tested 5-1/2" Casing w/ 1000# for 1/2 hr. before drilling cement - OK. Drilled cement from 9995' to 10065' and tested casing for 1/2 hour w/ 1000# - OK. Continued with completion operations -
