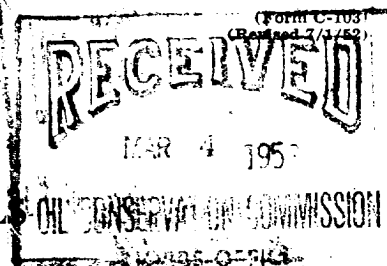

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

4230' - Total Depth - Lins. Finished drilling 11" holes @ 8:45PM, 2-28-53. Ran a total of 101 jts. of 8-5/8" OD Casing set @ 4230' w/ 1500 sk. cement. Plug pumped to 4140' @ 10:55AM, 3-1-53. Max pressure, 1700#. Ran temperature Survey - found top of cement outside 8-5/8" Casing @ 1888', or 50.4% fill. After WOC for 24 hours, tested 8-5/8" casing with 1100# before drilling cement - OK. Drilled cement from 4140' to 4230' and tested casing for 1/2 hour w/ 1200# - OK. Started drilling formation and 7-7/8" hole @ 1:36AM, 3-3-53.
