set at 296' with 250 sacks cement. Pumped plug to 281' at 9 AM, 8/8/52. Cement Circulated. After W.O.C. for 12 hours, tested csg. W/800# for 1/2 hour - no pressure drop. Drilled cement from 281' to 305' and tested casing with 800# for 1/2 hour - no pressure drop. Started drilling formation and 12-1/4" hole at 1:30 AM, 8/9/52 -
