DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

This well was drilled to a total depth of 4276' in line. Ran 114 joints, 4262' of 8 5/8" OD 32 and 24# casing set at 4276' and cemented with 1935 sacks containing 4% gel, 170 sacks strata crote and 400 sacks neat cement. Plug was down at 7:00 P.M. November 21, 1952. Cement was allowed to set 48 hours before testing for shut-off. Shut-off was tested with 1000 pounds pressure with all valves closed during a 30 minute period with no drop in pressure. Drilling was resumed.
