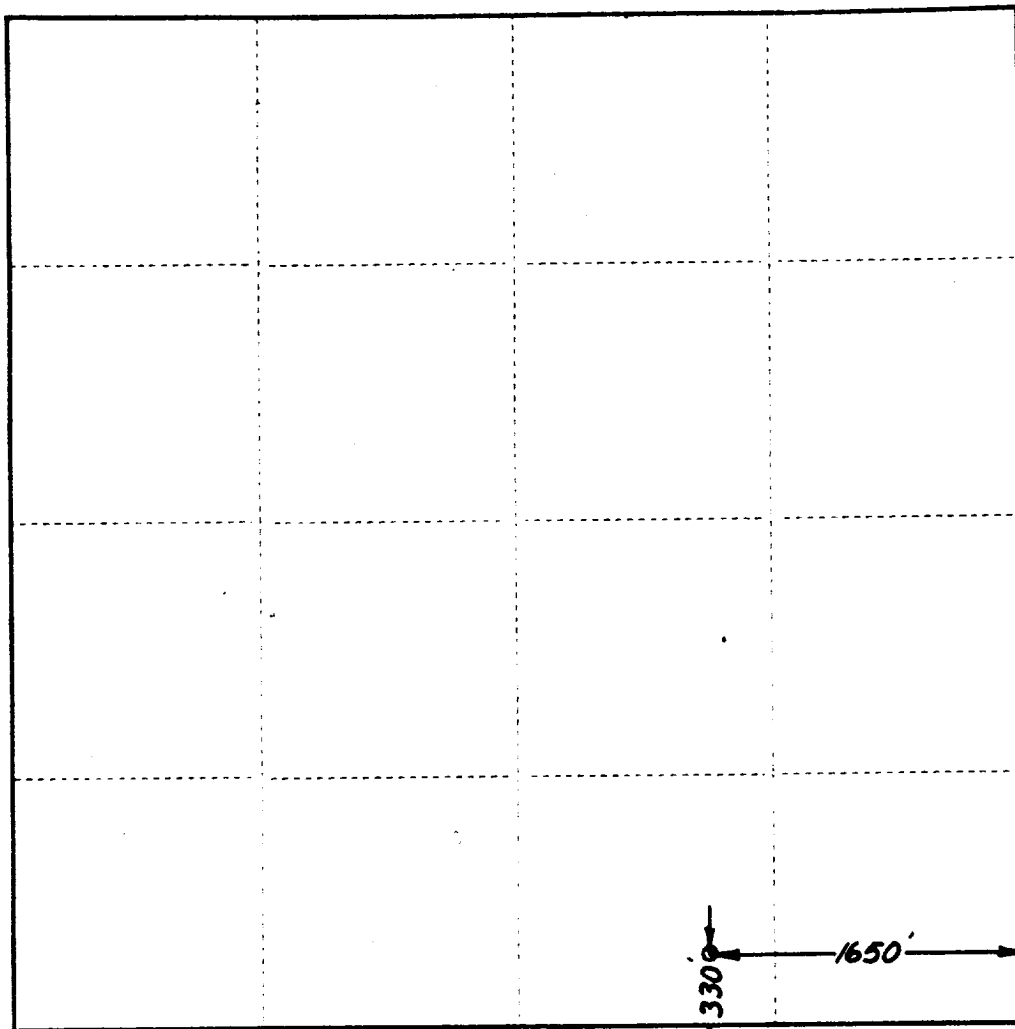


# WELL LOCATION SURVEY PLAT
