1. Run tubing and fill hole with fresh water
2. Spot 35 sx neat cement plug 4100-4410'
3. Pull tubing
4. Run casing free point indicator
5. Cut and pull casing
6. Run tubing and circulate and condition mud to weight of 8.5#/gal.
or more and viscosity of 30 seconds or more
7. Spot 50 sx neat cement plug over top of casing fish
8. Spot 50 sx neat cement plug at base of surface casing (300-400')
9. Cap well with 15 sx neat cement plug and erect prescribed 4" x 4' marker.
