FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

This well was drilled to a T.D. of 4765. Three hundred feet of Ban Andres was penetrated with no shows of oil, gas or water. It is planned to plug back to the Grayburg section and try to complete the well there. This will be done by set ting a Haliburton (Hamilt on) bridg e plug at 4485 in the San Andres. On top of this plug will be dumped 40° of Cal-Seal, which will bring the plug up into the Grayburg. Seven feet of lead wool will be tamped on top of the cal-Seal to try t o shut off water in the lower Grayburg. The lead wool in turn will be capped with 8° of Hydromit e. The well will then be plugged back to 4430.
