Drilled to a total depth of 3981'. No oil or gas in commercial quantities was encountered in any zones. We propose to plug to abandon as follows:

Spot 50 sacks cement at 3900', Base Salt 2625'-25 sacks, Top Salt 1715'-25 sacks, Bottom of 8-5/8" casing 144' - 25 sacks, and 10 sacks for surface cap. All intervals not filled with cement will be filled with heavy mud laden fluid.
