DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Drilled 12 1/2" hole to 4625'. Ran 142 jts of 9-5/8" J-55 and H-40 casing. Total casing 4603.29' set at 4623.69'. Cemented with 2800 sacks of Pozmix with 4% gel and 200 sacks of Lone Star Portland neat. Ran temperature survey. Found top of cement at 910' from surface. Tested 9-5/8" casing and BOP blanks with 1000# for 30 minutes OK. Drilled cement and guide shoe at 4623.69' at 6:30 PM 1-4-56. Drilled formation to 4630'. Pressured up to 800# for 30 minutes. Pressure held. Resumed drilling.
