Perforated casing in the interval 10,542'-10,571' with 4 holes per foot, ran straddle packer, treated new perforations with 9,000 gallons of acid. Pulled straddle packer, re-ran tubing with hookwall packer and swabbed well to flow.

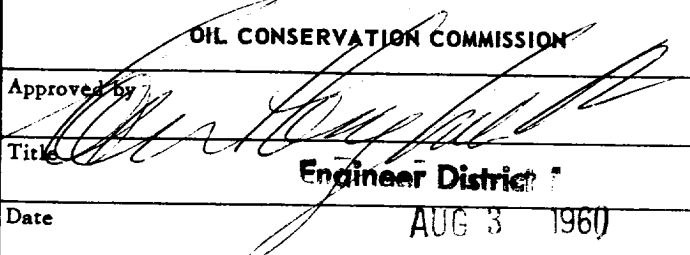
