PROPOSED OPERATION

1. Pull rods, pump, and tubing.
2. Perforate 10,210' - 10,217', 10,260' - 10,264', 10,272' - 10,277', 10,362' - 10,368', and 10,371' - 10,375' w/2JSPP.
3. Run retrievable bridge plug and packer on 2" tubing.
4. Treat perforations between bridge plug and packer w/6000 gallons 15% NEA.
5. Reset bridge plug and swab test all "new" perforations 10,210' - 10,375'.
6. If warranted set CIBP at 10,450' and abandon "old" perforations 10,469' - 10,532'.
7. Place on production.
