PROPOSED OPERATION

1. Pull rods, pump & tubing.
2. Perforate 5 1/2" casing 10,511' - 10,519', 10,522' - 10,528' w/2 jet shots per foot.
3. Run tubing w/packer and side door choke assembly. Set packer @ 10,540'.
4. Treat perforations above packer w/1000 gallons MCA. Swab test.
5. If necessary, treat w/3000 gallons 15% NEA. Swab test.
6. Pull tubing and packer. Rerun tubing, rods, pump and gas anchor.
7. Place all perforations on production.
