Ran 10,595' of 5-1/2" casing and cemented at 10,606' with 400 sacks 4% and 200 sacks neat cement. Did not circulate cement. After WOC 48 hours tested casing with 1500 psi for 30 minutes. Test OK. Drilled out to 10,571' and tested casing and cement with 1500 psi for 30 minutes. Test OK.
