PROPOSED OPERATION

1. Raise tubing to 11,415' leaving stinger thru Model D packer.
2. Run one-50 grains/foot followed by one-100 grains/foot string shot over perforated interval 11,475' - 11,506'.
3. Lower tubing to original setting and land back into packer.
4. Treat formation w/3000 gallons 15% NE acid.
5. Swab load.
6. Place on production.
