FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

1. Kill well. Raise tubing to 11,425' leaving stinger thru Baker Model D packer.
2. Set off a 25-foot 100 grains/ft. string shot followed by a 25-foot 200 grains/ft. string shot over perforated interval 11,475' - 11,506'.
3. Lower tubing to original setting and set seal nipple in packer.
4. Spot 1000 gallons 15% MCA on bottom. Let soak 1 hour. Inject acid to formation.
5. Swab lead.
6. Place on production.
