DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On January 26, 1953 at 7:30 P. M., 36 hours had elapsed since running 4586' of new 9-5/8" casing landed at 4500' and cemented in two stages as follows:

1st stage: Cemented through staging collar set at 2261' with 450 sacks cemented mixed 8% gel plus 100 sacks neat cement. (Top cement indicated at 2175 by temperature survey.)

2nd stage: Cemented with 150 sacks neat cement.

Casing shut off was tested with 1400 psi for 30 minutes before and after drilling staging tool, and 1200 psi for 30 minutes after drilling casing shoe. Since there was no appreciable drop in pressure on any test, drilling operations were resumed.
