State "4" No. 1 TD 10,437': Casing: 13-3/8" @ 300' w/300 sax Perfs: 10,297-10,353.  
9-5/8" @ 4572 w/3000 sax  
7" @ 10,401 w/700 sax

We propose to plug the subject well in the following manner:

1. Displace fluid in hole with drilling mud.
2. Equalize 25 sacks of cement at 10,355'.
3. Cut off 7-inch casing at free point. Spot a 25 sack cement plug in top of 7-inch casing stub.
4. If top of 7-inch casing stub is below top of Glorieta formation (6147') then equalize a 25 sack cement plug at 6160'.
5. Equalize 25 sacks of cement in the base of 9-5/8-inch casing @ 4572'.
6. Spot a 10 sack cement plug in the top of the 9-5/8-inch casing at surface with a 4-inch pipe set in concrete extending 4' above ground level.
