Plug back depth 10,751 feet.
Acidized with 500 gallons Western L. T. acid, reperforated with 4 Welox jet shots per foot from 10,714 to 10,695'. Acidized with 1500 gallons Western L. T. acid and 3000 gallons Western Special L. T. acid with I-5 additive. Drilled cement to 10,751', perforated 5-1/2" casing 10,728 to 10,743' with 4 Welox jet shots per foot, total of 60 shots.

On 1-30-54 on 13 hour bleed-down test scrubbed 81.67 barrels fluid, 79.17 barrels water, 2.50 barrels oil.
