Cemented with 375 sacks 4% gel Portland cement. Plug on bottom at 2:15 P.M., 11-17-54. Pressure 400#, circulated 30 sacks cement.

Tested casing with 800# CWP for 30 minutes. Tested O.K. No drop in pressure.

Resumed drilling.
