Remove rods, pumping equipment and pumping unit. Tubing head and tubing string to be left on well. Well shut in and capped with 2" 3000# test gate valve. Well temporarily abandoned pending decision on possibility of remedial work at a later date. Last test on September 1, 1960, well would only pump 1.38 barrels oil in 24 hours and is uneconomical to produce.
