Spudded 11:00 P.M. 12-9-52: Drilled 15" hole to 390' in Red bed, ran 11 jts, 354', of 11-3/4" OD 8 rd Thrd, 42#, H-40, size 2 & 3 csg with HCNCO guide shoe set at 374'. Cemented with 450 sacks of Portland bulk cement. Pumped plug to 350', estimated 35 sacks of cement returned to cellar. Let set 36 hours, tested with 1000# for 30 min, held OK.
