Spudded 12-1/4" hole 2:15 PM 5-7-55, completed 17-1/4" hole 5-9-55 at 372'. Ran 11 jts 350' of 11-3/4" OD 8 rd thd, 42#, H-40, R-1 & 2, NSS casing with Larkin guide shoe set at 367'. Cemented with 850 s acks Longhorn Portland Neat cement, pumped plug to 357', maximum and final pressure 300#. Set 36 hours and tested 11-3/4" casing with 1000# for 30 minutes, held OK.
