We propose to re-enter subject well which was drilled as the Louisiana Land and Exploration Company No. 1 State well, plugged and abandoned February 5, 1954. It is our intention to clean out to plug at 4900 feet, run Gamma Ray-Neutron log, set drillable cast iron bridge plug at 4250 feet, and perforate Queen sandstone section from Gamma Ray-Neutron log. We plan to treat through perforations with 500 gallons mud acid and sand frac with 30,000 to 40,000 gallons oil.
