T.D. 13,596'. Set 5-1/2" casing at total depth, cemented with 300 sacks cement. Perforated casing from 13,576' to 13,596' with 80 shots and washed with 5 barrels acid; swabbed and recovered approximately 20 barrels of oil. Raised packer, acidized with 1,000 gallons and ran swab; well kicked off and flowed 85-1/2 barrels the first hour and 93 barrels the second hour on 1/2" choke. Tubing Pressure - 350#
