Total Depth 4750' Dolomite & Lime. Ran 114 joints of 10-3/4" Grade J-55 casing set @ 4741.50'. Cemented w/2770 sacks of cement w/3% gel and 200 sacks Neat cement preceded by 20 bbls. Smentox treated water. Plug pumped down at approximately 7:30 a. m. 3-24-1955. Cement did not circulate. Top of cement 1400'. Tested casing w/1000# pressure for 30 minutes. Test ok.
