1-22-59 Perforated Permo-Penn Zone from 10380-10395 & 10630-10665 w/4 jet shots per foot.

1-23-59 Ran Devonian Tubing to 13520 w/Guiberson Packer set at 11017. Ran 2-3/8" OD Tubing to 10885 (Penn. Zone.).

1-24-59 Acidized Permo-Penn Perfs 10380-10395 & 10630-10665 w/4500 gals regular acid. Max Press 3700#, Min Press 3700#, Inj rate 5.5 BPM, 10 min SIP 1800#. Unseated Guiberson Packer at 11017.

1-26-59 Flowed & recovered lead oil. On Potential Test well flowed 209 bbls new 43.7 gravity oil thru 14/64" choke. Tbg Press 425#, Csg Press-Zero, GOR 911, for a 24 hour calculated potential of 264 bbls oil per calendar day. Recompleted. Allowable raised from 59 bbls per day to 227 bbls per calendar day effective 1-27-59. Final Report.
