DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

This well was drilled to a total depth of 3320' in line. Ran 95 1/10 joints 8 5/8" OD 32 and 24 1/2 casing, 3305.08 set at 3319.28 and cemented with 1764 sacks with 4% gel, 110 sacks strata crete and 400 sacks neat cement. Plug was down at 12:25 P.M. November 19, 1952. Cement was allowed to set 48 hours, casing shut-off was tested with 1000 pound pressure with all valves closed during a 30 minute period with no drop in pressure. Drilling was resumed.
