DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On November 26, 1954, we ran 4737' of new 9-5/8" casing, set at 4750' with staging tool at 2300'. Cemented in two stages; 1st stage: 213 sacks 8% gel plus 100 sacks neat. 2nd stage: 150 sacks neat. After WOC for 30 hours, tested casing before and after drilling plug with 1000 psi for 30 minutes. Test OK, resumed drilling operations.
