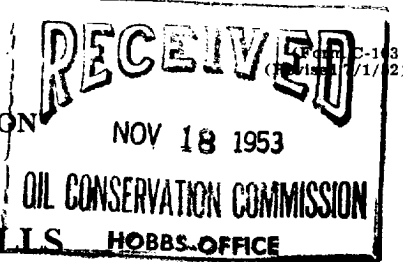

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 12,266' of 5 1/2" casing and cemented at 12,281' with 500 sacks 4% gel and 800 sacks neat cement. Did not circulate. Left 67' cement in casing. After WOC 8 hours ran temperature survey and found top of cement in annulus at 7450'. Stretch test indicated freeze point at 8690'. After WOC 56 hours tested casing and cement with 1500 psi for 30 minutes before and after drilling plug. Test OK.
