RECOMPLETE FROM DEVONIAN TO WOLFCAMP

1. Pull rods, pump and tubing.
2. Set CIBP @ 9450'. Run GR/CLL from 9450' - 8950'. If fluid level above BP, run tubing w/packer and displace water w/oil.
3. Perforate Wolfcamp thru tubing 9270' - 9274', 9280' - 9292', 9302' - 9326', & 9360' - 9368' w/2JSPF.
4. Wash and treat perforations w/1000 gallons MCA. Swab test.
5. If necessary, acidize w/10,000 gallons NEA. Swab test.
6. Pull packer, rerun tubing, rods & pump.
7. Place on production.
