We propose to do the following:

1. Pull rods, pump & 2 1/2" tubing.
2. Run 2" tubing open-ended with packer on bottom and set packer @ 12,340'±.
3. Treat formation with 10,000 gallons 15% acid using rock salt as staging material.
4. Swab test.
5. If well does not flow, pull 2" tubing & rerun 2 1/2" tubing, pump & rods.
6. Place on production.
