## DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

TD 4770 - Set 9 5/8" OD casing @ 4768 and cemented with 2350 sacks of cement. Ran temperature survey which indicated top of cement behind 9 5/8" OD casing @ 1290 from surface. Let set 48 hours and tested with 1000# pump pressure for 30 minutes before and after drilling cement plug. No decrease in pump pressure. Resumed drilling.
