TD - 4790 - Set 9 5/8" OD casing @ 4789' and cemented with 2630 sacks of cement. Run temperature survey which indicated top of cement @ 1540' from surface. Let cement set 48 hours and tested with 1000# for 30 minutes before and after drilling cement plug. No decrease in pump pressure. Resumed drilling.
