Set 8001' of 5-1/2" OD Liner @ 12,640', top @ 4639', W/100 sacks 8% gel, 100 sacks neat, perforated 5-1/2" Liner @ 11,325' W/2 - 1/2" holes, squeezed perforations W/1700 sacks 6% gel, 100 sacks neat @ 500#, pump and plug method, did not circulate, tested top of Liner @ 4639' W/3500# 30 minutes, broke, squeezed top of Liner W/100 sacks 6% gel and slosset @ 3000#, tested top of liner W/3500# 30 minutes, no break, tested perforations W/2000# 30 minutes, no break.
