Set 4787' of 5 1/2" liner at 9446, top of liner @ 4659, cemented w/232 sacks 4% gel, 200 sacks neat. W.O.C. 10 hrs. Top of cement at 6200'. Squeezed top of liner @ 4659 w/150 sacks 4% gel, 150 sacks neat w/1800# pressure. W.O.C. 24 hours. Did not circulate cement.

Tested top of liner with 2000# for 30 minutes before and after drilling plug -- no break.
