FULL DETAILS OF PROPOSED PLAN OF WORK

(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

The following is a proposed plan for the temporary abandonment of our B.C. Dickinson "D" well No. 9 in the Denton (Wolfcamp) Field. Remove rods and tubing from well and set by means of a wire line, a bridge plug in the bottom joint of 5 1/2" casing. Then dump two (2) sacks of cement on top of bridge plug. Install valves on casinghead of each string of casing and operating pressure gauges. Following the temporary abandonment operations and at 6-month intervals; thereafter, a form C-103, Miscellaneous Reports on Wells, will be submitted to the Commission showing present status of well including pressures and any future plans.
