TD 305 - Set 13 3/8" casing @ 305 and cemented with 325 sacks of common cement. Cement circulated to surface.

Let set 24 hours and tested with 1,000# pump pressure for 30 minutes, drilled cement plug and retested with 1,000# for 30 minutes, no decrease in pressure so resumed drilling.
