TD 4790 - set 9 5/8" OD casing @ 4788 and cemented with 2,400 sacks of cement. Ran temperature survey which indicated top of cement behind 9 5/8" casing @ 1310' from surface. Let cement set 48 hours and tested with 1125# pump pressure for 30 minutes before and after drilling cement plug. No decrease in pressure. Resumed drilling.
