TD 4790, set 9 5/8" OD casing @ 4789 and cemented with 2400 sacks cement. Ran temperature survey which indicated top of cement back of 9 5/8" casing @ 1140 from surface. Let cement set 48 hours and tested with 1,000# pump pressure for thirty minutes before and after drilling cement plug. No decrease in pressure, resumed drilling.
