TD - 4780 - Set 9 5/8" casing @ 4779 and cemented with 2600 sacks of cement. Ran temperature survey which indicated top of the cement behind 9 5/8" casing @ 1610 from surface. Let cement set 48 hours and tested casing with 1,000# for 30 minutes before and after drilling cement plug. No decrease in pressure. Resumed drilling.
