PROPOSED OPERATION:

1. Run 2 1/2" tubing w/Lynes straddle packers spaced approximately 50' apart. Set packers at 12,570' - 12,620'. Swab test below and between packers.
2. Treat either or both zones w/6000 gallons 15% acid as warranted.
3. Reset packers at 12,520' and 12,570' and swab test between packers.
4. Treat w/3000 gallons 15% acid.
5. Run production string & place on production.
