1. Rig up, kill well, install BOP & POH w/compl assy.
2. RIH w/RBP & RTTS pkr, locate leak, set BP 100' below csg leak. Set pkr above leak & establish circ. Spot 2 sx sd on top of BP.
3. Set RTTS pkr 200' above leak & cmt squeeze hole in csg w/cmt volume & class to be determined by depth and inj rate. WOC.
4. Drill out cmt squeeze & pressure test to 500# for 30 mins.
5. Circ sd off BP & retrieve.
6. RIH w/compl assy, set pkr @ approx 10,000' & return to production.
