After drilling to 9296', ran 7" casing and cemented in two stages as follows:  
Cementing collar set at 6980, cemented first stage with 250 sax  $\frac{3}{8}$  gel and 100 sax neat cement. Plug down at 4:50 AM, 2-18-53. Cemented second stage with 500 sax cement and 500 sax Pomix with 2% gel in the 1000 sax and 200 sax neat cement. Plug down at 12:21 PM, 2-18-53. Will wait 36 hours and test casing.
