DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 268 joints & cut jt. 9462' of 7" OD 8 RT R-2 & 3, 26 & 23# SS casing. Set and cemented at 9473' w/360 sacks Trinity slow set 4% Gel Cement. Plug at 9402'. Gulf temperature survey found top cement 7515' below rotary table.

After waiting over 30 hours tested 7" casing w/1200# pressure for 30 min. There was no drop in pressure. Drilled cement from 9300' to 9445'. Tested casing w/1200# pressure for 30 minutes. There was no drop in pressure.

After approval of Mr. Yarbrough, State Oil and Gas Inspector, preparations were made to complete well.
