DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 133 joints & nipple 4695.76' of 9-5/8" OD 8 RT 36# & 40# J-55 Youngstown SS casing. Set and cemented at 4709' w/1675 sacks 43 gel Lonestar cement and 125 sacks Neat on bottom. Maximum pressure 1200#. Plug at 4606'. Gulf temperature survey found top cement at 2335'.

After waiting over 30 hours tested 9-5/8" casing w/1000# pressure for 30 minutes. There was no drop in pressure. Drilled cement from 4606' to 4709'. Tested cement below casing shoe w/600# pressure for 30 minutes. There was no drop in pressure.

After approval of Mr. Yarbrough, State Oil and Gas Inspector, preparations were made to drill ahead.
