DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 141 joints 4682.15' of 9-5/8" OD 8 RT 36# S-80 & J-55 SS casing. Set and cemented at 4699' w/1825 sacks cement, 1700 sacks 4% Gel Lonestar & 125 sacks Neat Trinity on bottom. Plug at 4612'. Maximum pressure 1400#. Ran Gald temp survey after 10 hours, found top cement outside 9-5/8" casing at 1604' below rotary table.

After waiting over 30 hours tested 9-5/8" casing w/1000# pressure for 30 min. There was no drop in pressure. Drilled cement plug from 4612' to 4700', tested cement below casing shoe w/500# pressure for 30 minutes. There was no drop in pressure.

After approval of Mr. Yarbrough, State Oil and Gas Inspector, preparations were made to drill ahead.
