GULF FW 636

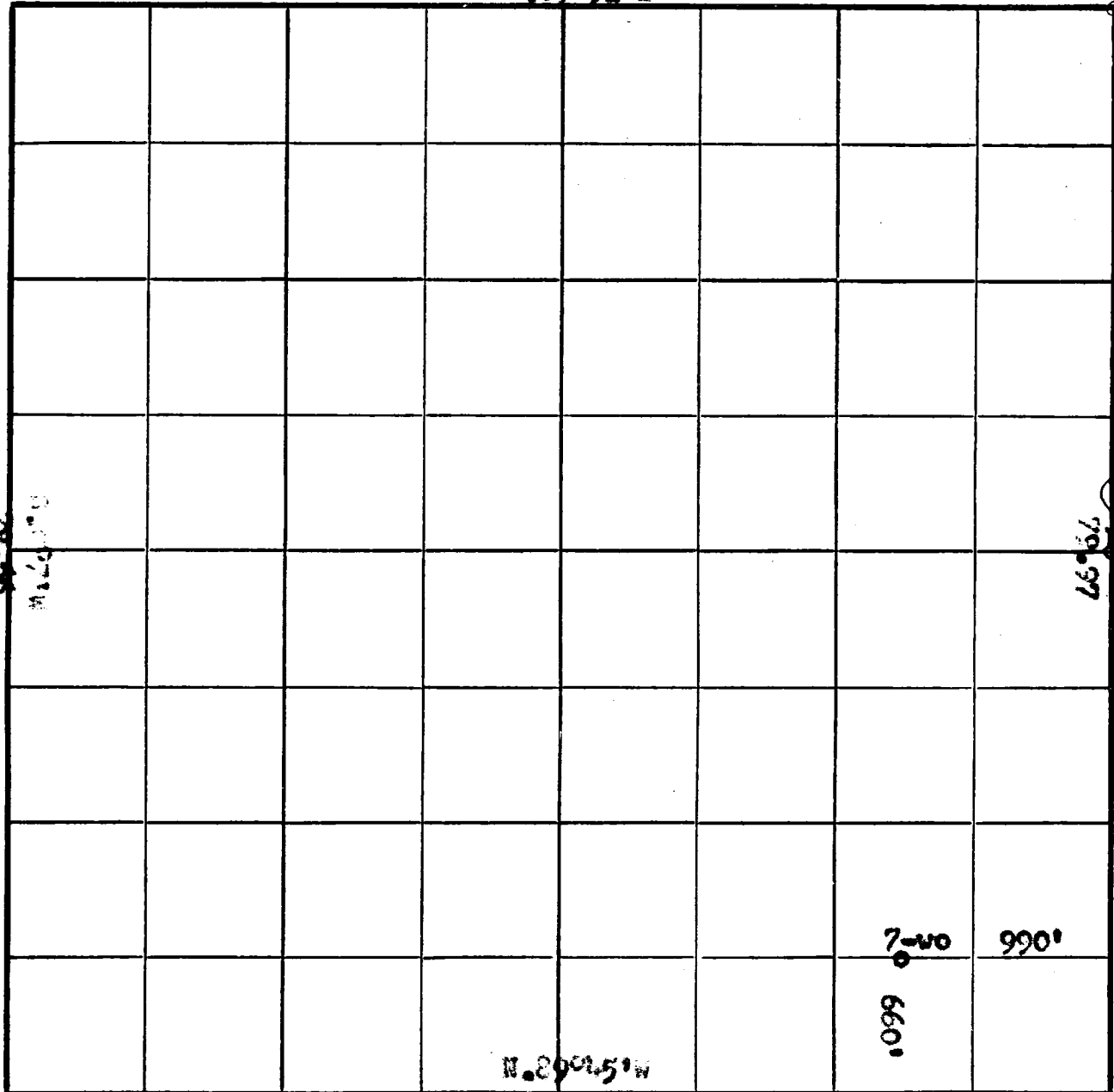
