DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 117 joints 4647' of 9-5/8" OD 40# J-55& N-80 SS Casing. Set and cemented at 4659' w/2800 sacks cement, 2700 sacks 4% Gel, 150 sacks Neat on bottom. Plug at 4375'. Maximum pressure 1000#. Gulf temperature survey in 8 hours showed top of cement at 1475'.

After waiting over 30 hours tested 9-5/8" casing w/1000# pressure for 30 minutes. There was no drop in pressure. Drilled cement plug from 4375' to 4659'. Tested cement below casing shoe w/500# pressure for 30 minutes, there was no drop in pressure.

After approval of Mr. Iarbrough, State Oil and Gas Inspector, preparations were made to drill ahead.
