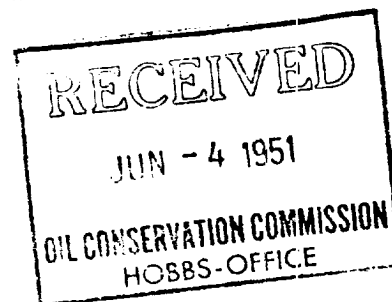

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Drilled to total depth of 4800'. Ran 9-5/8" casing to 4800' and cemented with 3700 sacks. The Halliburton process was used and temperature survey showed top of cement at 340'. Let cement set 48 hours and on May 31, 1951, at approximately 4:00 A.M. drilled plug and tested casing shut-off. Shut-off tested OK.
